## Background and aim of the Conference

Through its EUR-OPA Major Hazards Agreement, the Council of Europe is promoting improvements in emergency planning, disaster response and risk mitigation for migrants, refugees and asylum seekers.

International population movements pose a challenge to member states in particular in the context of disaster risk management for vulnerable groups; policies and practices have to be adjusted for the greater mobility of people, and the increasingly complex relationship between risk and mobility. For those currently working in civil protection, this is an unfamiliar issue. Many agencies seem to be responding to situations instead of anticipating them. Civil protection organisations need to take the specific needs of migrants, asylum seekers and refugees into account in their interventions.

The Resolution on “Ethical principles relating to disaster risk reduction and contributing to people’s resilience to disasters”<sup>1</sup>, is the basis for the current EUR-OPA work programme. The Council of Europe has convened a working group to produce a survey of current developments in Europe on migrants, asylum seekers and refugees in the context of major risks prevention and management. A Training Workshop took place in the summer on “Reducing the vulnerability of migrants in emergency situations”<sup>2</sup>. This event will be followed by an implementation workshop in one of the member states.

At the conference, a compilation of good practices, guidelines for action and a declaration with recommendations for action across Europe will be discussed; these documents will be formally adopted at the 13<sup>th</sup> Ministerial Session of the European and Mediterranean Major Hazards Agreement<sup>3</sup>. Discussions at the Conference will focus on how to take forward initiatives in this field in order to improve the quality of services designed to support migrants, asylum seekers and refugees who are confronted with emergencies or disaster risk.

Migration is predominantly an urban issue, since towns and cities are the main destination for migrants, refugees and asylum seekers. A broad-based, flexible and inclusive approach is taken, looking beyond the current refugee crisis. Civil protection should work with many other support organisations and groups, including the formal and informal organisations of migrants, refugees and asylum seekers themselves. There is an important role for civil society organisations of many kinds to give practical help, show solidarity and cultural exchange.

The results of this project will be a contribution to The Sendai Framework for Disaster Risk Reduction 2015-2030<sup>4</sup>.
