Bom dia,

No âmbito da cooperação interparlamentar na União Europeia, junto envio os seguintes documentos relativos à Semana Parlamentar Europeia e à Conferência Interparlamentar sobre Estabilidade, Coordenação e Governação Económica na União Europeia (CIP ECGE UE), que decorrerão em Bruxelas, nos dias 30 de janeiro a 1 de fevereiro de 2017:

De acordo com o Regulamento da Conferência Interparlamentar sobre Estabilidade, Coordenação e Governação Económica na União Europeia, cada Parlamento nacional determina a composição e dimensão da delegação a esta Conferência. Relativamente à Assembleia da República, cumpre referir que tem sido sempre designada uma delegação composta por Deputados das Comissões de Assuntos Europeus, Orçamento, Finanças e Modernização Administrativa e de Trabalho e Segurança Social.

Nas duas Conferências Interparlamentares realizadas nesta Legislatura, as delegações da Assembleia da República foram compostas por 3 Deputados do PSD, 3 Deputados do PS (em ambos os casos, um indicado por cada comissão envolvida) e 1 Deputado representando, rotativamente, o BE, CDS-PP e PCP (nas referidas Conferências, integraram a delegação um Deputado do BE na primeira e um Deputado do CDS-PP na segunda, cabendo desta vez ao PCP).

A delegação é assessorada pelo Representante Permanente da AR junto da UE e, normalmente, pelo assessor de uma das comissões envolvidas – a quem caberá coordenar a inscrição, logística e preparar as pastas. Por se tratar de reunião a decorrer no Parlamento Europeu, tratarei, como é hábito, da inscrição.

As inscrições devem ser efetuadas até dia 13 de janeiro de 2017.

Tendo presente o exposto, **coloca-se à consideração das Comissões de Assuntos Europeus; de Orçamento, Finanças e Modernização Administrativa; e de Trabalho e Segurança Social a designação de 7 Deputados que integrem a delegação da Assembleia da República, seguindo a prática instituída aquando da participação na última conferência: 1 Deputado do PSD e 1 do PS por comissão, cabendo ao PCP indicar 1 Deputado – num total de 7 Deputados.**



Further to the publication of the Five Presidents' report, the Commission is planning to release in spring 2017 a white paper including measures to complete the EMU. Additional initiatives could be expected in the context of the celebration of the 60th anniversary of the treaty of Rome. The purpose of the discussion would be to take stock of the strength and weaknesses of the current economic governance framework and to assess measures that would still be needed in order to provide input to this work from a parliamentary perspective. *The Treaty on Stability, Coordination and Governance in the Economic and
Monetary Union foresees in its Article 16 that: “Within five years, at most,
of the date of entry into force of this Treaty, on the basis of an assessment of
the experience with its implementation, the necessary steps shall be taken, in
accordance with the Treaty on the European Union and the Treaty on the
Functioning of the European Union, with the aim of incorporating the
substance of this Treaty into the legal framework of the European Union.”
As this deadline is set to end 2017, it is important to assess the
implementation of the fiscal compact and the measures to be adopted to
incorporate its provisions into the EU legal framework.*

The Commission launched on 8 March 2016 a consultation with the aim:

- *To make an assessment of the present EU social "acquis": Which existing rights are practiced and remain relevant for today's and tomorrow's challenges? Should we consider new ways to deliver on these rights?*
- *To reflect on new trends in work patterns and societies: What has been the impact of new technologies, demographic trends and other factors on our working life and social conditions? Which best practices and lessons from social innovation should be actively encouraged?*
- *To gather views and get feedback on the outline of the European Pillar of Social Rights itself and help Member States outside the euro area to determine whether to opt in: What will be the role, scope and content of the Pillar as part of the social dimension of EMU? What are the euro area's needs? What are the challenges related to the principles put forward under the Pillar?*

The consultation process should be concluded by 31 December 2016 and will constitute the basis for the new Commission's final proposal for the Pillar to be delivered in early 2017.

The implementation of reforms and measures to foster growth and jobs across the EU is still rather heterogeneous and a lack of coordination sometimes materializes among Member States. The Eurogroup has undertaken to benchmark national reforms and, when possible, establish best practices in order to facilitate reforms to be debated at national level. In the context of Article 9 of the fiscal compact it would be worthwhile to

explore how to further enhance cooperation and sharing of best practices among national Parliaments to deliver structural reforms for growth and jobs.



At its annual meeting in autumn 2016 the European Stability Mechanism (ESM) agreed to start an evaluation process of former stability support programmes to carefully examine the financial support provided in past programmes and to draw lessons from them with the aim of increasing the efficiency and effectiveness in the future. It also decided to publish more programme-related documents. Today Cyprus, Ireland, Portugal and Spain are subject to post-programme surveillance by the Commission, while Greece is still subject to its third macro-economic adjustment programme: the ESM is by far the largest creditor to Greece, with more than €160 billion disbursed from the EFSF and the ESM.
