Dear Colleague,

The Directive 2006/123/EC ("the Services Directive") offers a number of benefits to domestic and foreign service providers; however, the complete implementation of the Services Directive is crucial in order for them to actually be able to reap those benefits. The deadline for the transposition of this Directive expired on 28 December 2009.

A number of difficulties have been experienced in the process of screening of the existing legislation and adoption of the horizontal implementing laws as well as setting-up the fully-operational Points of Single Contact. The European Parliament and the national parliaments should address those issues and thus contribute to the removal of the remaining obstacles that hinder businesses from fully benefiting from the Services Directive.

Due to these and other outstanding issues my Committee proposes to organise a meeting with the National Parliaments on the subject "Making the Internal Market for Services Work: State of Play and Challenges Ahead". The proposed event would be held on **Tuesday 27 April 2010** from 15:00 to 17:30 at the European Parliament in Brussels.

I would like to invite a maximum of two representatives from every National Parliament to participate at the event and to make a short presentation of your Committee's views on the subject. Should you be unable to attend, we would welcome any written contribution which could be distributed to our respective Members and other participants.

Please find attached the draft programme for the meeting. The practical details regarding the meeting will be forwarded to your Parliament's Representatives/Services directly responsible for relations with the European Parliament.

I am looking forward to your participation in our debates.
