

Dear Distinguished Colleague:

As co-chair of the NATO Observer Group in the United States Senate, I invite you to join me in attending the next Parliamentarian Intelligence-Security Forum to be held on December 6-7. 2022 in Washington D.C. in Dirksen Senate Office Building, Committee Hearing Room 106.

The Parliamentarian Forum plays an absolutely critical role in bolstering the national security posture of free countries around the world by facilitating and enhancing longstanding relationships with our allies, informing parliamentarians and other legislative branch officials about important issues of public policy relating to our collective economic and national security, and countering the conventional and non-conventional threats posed by our adversaries, including China, Russia, Iran, and North Korea.

I applaud the Forum for its strong moral compass and consistent message regarding the war in Ukraine. There can be no doubt: Putin must be severely punished for his illegal actions and provocations, and coordinated economic sanctions on Russia must be implemented and sustained. The U.S. and our allies must stand with the Ukrainian people, ensuring its military has the weapons it needs to defend its citizens and sovereignty from Russia's aggression.

Similarly, we need to be unified in our support for imposing sanctions on the government of Iran, which continues to build up its ballistic missile capabilities and remains the world's largest state sponsor of terrorism.

I also commend the Forum for its clear-eyed understanding that the Chinese Communist Party poses a grave geopolitical threat to democracy and freedom around the world. For our own security, we need to contain the Chinese government in the long-term and reduce their military, technological, and economic ambitions, including ways to reduce our dependency on China by moving our manufacturing away from China. We cannot afford to sugarcoat the ambitions of the Chinese government: their ultimate goal is to realign the international system to serve China's nefarious interests.

History has repeatedly proven that appearement never works. As a United States Senator, I will do everything in my power to protect the national security of the U.S. and maintain our position
