Date and venue of the Conference:

The Conference opens on 10 September 2014 in the Croatian Parliament. The other part of the Conference will be held in Mali Lošinj on the island of Lošinj. There will be an organized transport to Mali Lošinj for all the participants in front of the Croatian Parliament building on 11 September 2014 at 3 p.m. as well as to the Zagreb airport.
