

I would like to update you on the OECD's activities with parliamentarians:

#### Upcoming events

The OECD would like to invite you to the 4<sup>th</sup> OECD Parliamentary Days which will take place at the OECD Conference Centre in Paris on 3-5 February 2016. This will include:

- A meeting of the OECD Global Parliamentary Network on 4-5 February, held jointly with the NATO Parliamentary Assembly annual meeting at the OECD and with the participation of Women in Parliaments Global Forum; The following sessions are currently foreseen: a conversation with the OECD Secretary-General, financing democracy, strategic foresight, OECD resources for parliaments, the World Energy Outlook and next steps after COP21, the peer-to-peer (P2P) economy, combating terrorist financing, and finance and inclusive growth.
- Bilateral meetings between OECD experts and parliamentary delegations on 3 (all day) and 5 February (afternoon only). This meeting will offer an opportunity for Members of Parliament and OECD experts to engage in dialogue on a range of key topics that are not already part of the meeting agenda.
- An OECD iLibrary stand during the Network meeting and two iLibrary information sessions on 3 and 5 February.
- An evening reception for participants on 4 February

The event is open to Members of Parliament and parliamentary officials from OECD and partner countries. - The next meeting of the OECD Global Parliamentary Network "on the road" will take place in Tokyo in mid-April 2016, hosted by the Japanese Diet. We will provide you with further information closer to the date.
- Looking further ahead, the OECD Forum 2016 on the topic of Inclusive Growth will take place in Paris next 31 May and 1 June 2016. The Forum will bring together members of civil society, business, trade unions, academia, parliaments, and media to share policy suggestions and concerns with governments. We will provide you with further information closer to the date.

#### Recent OECD events with parliamentarians

- On 5-6 December, a parliamentary meeting on the occasion of the COP21 took place in Paris, jointly organised by the Inter-Parliamentary Union and the French Parliament. The OECD Secretary-General Angel Gurría spoke on 6 December on the topic of "Leading the world towards a green economy". His remarks are available [here](#).

- The Secretary-General addressed parliamentarians at the [GLOBE COP21 Legislators Summit](#), that took place on 4-5 December 2015 at the National Assembly in Paris. His speech is available [here](#).
- On 19 October 2015, the [OECD Parliamentary Group on Tax](#) met in Paris. The meeting took place shortly after the release of the final OECD/G20 Base Erosion and Profit Shifting (BEPS) package in order to discuss its legislative implications for national parliaments early in the implementation process. In total, 22 Members of Parliament and 21 parliamentary officials attended the meeting, representing 16 countries. The PowerPoint presentations by the speakers can be found on this [page](#). A summary of the meeting will be available shortly.
- The [OECD Global Parliamentary Network](#) met in Paris on 1 October 2015. The meeting kicked off with a reception held at the French Senate on 30 September. 43 Members of Parliament and 21 parliamentary officials from 22 countries attended the meeting: Argentina, Belgium, Cameroon, Chile, Congo, Brazzaville, Czech Republic, France, Hungary, Ireland, Italy, Japan, Latvia, Lithuania, Luxembourg, Mexico, Poland, Romania, Russia, Slovak Republic, Slovenia, Spain and Sweden. - The Secretary-General spoke at the enlarged [Parliamentary Assembly of the Council of Europe](#) in Strasbourg on 30 September as part of the annual debate on the activities of the OECD. His speech is available on this [page](#).

##### [Policy Brief: Three steps to a low-carbon economy](#)

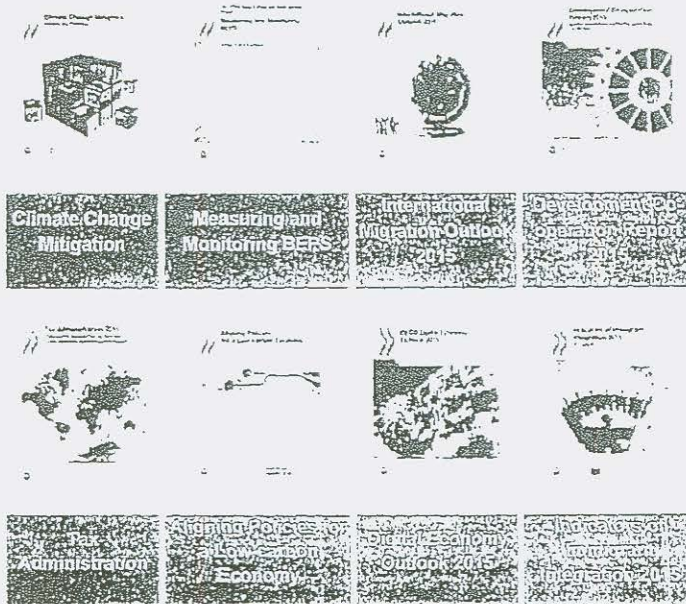
