#### Resolução da Assembleia da República n.º 7/2004

Aprova, para ratificação, o Protocolo ao Tratado do Atlântico Norte sobre a adesão da República da Estónia, assinado em Bruxelas em 26 de Março de 2003.

A Assembleia da República resolve, nos termos da alínea i) do artigo 161.º e do n.º 5 do artigo 166.º da

Constituição, aprovar, para ratificação, o Protocolo de Adesão da República da Estónia ao Tratado do Atlântico Norte, assinado em Bruxelas em 26 de Março de 2003, cujo texto, nas versões autênticas nas línguas inglesa e francesa e respectiva tradução em português, se publica em anexo à presente resolução.

#### PROTOCOL TO THE NORTH ATLANTIC TREATY ON THE ACCESSION OF THE REPUBLIC OF ESTONIA

The Parties to the North Atlantic Treaty, signed at Washington on April 4, 1949, being satisfied that the security of the North Atlantic area will be enhanced by the accession of the Republic of Estonia to that Treaty, agree as follows:

#### Article I

Upon the entry into force of this Protocol, the Secretary General of the North Atlantic Treaty Organisation shall, on behalf of all the Parties, communicate to the Government of the Republic of Estonia an invitation to accede to the North Atlantic Treaty. In accordance with article 10 of the Treaty, the Republic of Estonia shall become a Party on the date when it deposits its instrument of accession with the Government of the United States of America.

#### Article II

The present Protocol shall enter into force when each of the Parties to the North Atlantic Treaty has notified the Government of the United States of America of its acceptance thereof. The Government of the United States of America shall inform all the Parties to the North Atlantic Treaty of the date of receipt of each such notification and of the date of the entry into force of the present Protocol.


#### Article III

The present Protocol, of which the English and French texts are equally authentic, shall be deposited in the Archives of the Government of the United States of America. Duly certified copies thereof shall be transmitted by that Government to the Governments of all the Parties to the North Atlantic Treaty.



**PROTOCOLE AU TRAITÉ DE L'ATLANTIQUE NORD SUR  
L'ACCESSION DE LA REPUBLIQUE D'ESTONIE**

Les Parties au Traité de l'Atlantique Nord, signé le 4 avril 1949 à Washington, assurées que l'accession de la République d'Estonie au Traité de l'Atlantique Nord permettra d'augmenter la sécurité de la région de l'Atlantique Nord, conviennent ce qui suit:

**Article I**

Dès l'entrée en vigueur de ce Protocole, le Secrétaire Général de l'Organisation du Traité de l'Atlantique Nord enverra, au nom de toutes les Parties, au Gouvernement de la République d'Estonie une invitation à adhérer au Traité de l'Atlantique Nord. Conformément à l'article 10 du Traité, la République d'Estonie deviendra Partie à ce Traité à la date du dépôt de son

instrument d'accèsion auprès du Gouvernement des États-Unis d'Amérique.

### Article II

Le présent Protocole entrera en vigueur lorsque toutes les Parties au Traité de l'Atlantique Nord auront notifié leur approbation au Gouvernement des États-Unis d'Amérique. Le Gouvernement des États-Unis d'Amérique informera toutes les Parties au Traité de l'Atlantique Nord de la date de réception de chacune de ces notifications et de la date d'entrée en vigueur du présent Protocole.


### Article III

**PROTOCOLO DE ADESÃO DA REPÚBLICA DA ESTÓNIA  
AO TRATADO DO ATLÂNTICO NORTE**

As Partes no Tratado do Atlântico Norte, assinado em Washington em 4 de Abril de 1949, convictas de que a adesão da República da Estónia ao Tratado do Atlântico Norte permitirá reforçar a segurança da área do Atlântico Norte, acordam no seguinte:

**Artigo I**

Após a entrada em vigor do presente Protocolo, o Secretário-Geral da Organização do Tratado do Atlântico Norte, em nome de todas as Partes, enviará ao Governo da República da Estónia um convite para aderir ao Tratado do Atlântico Norte. Nos termos do artigo 10.º do Tratado, a República da Estónia tornar-se-á Parte no referido Tratado na data de depósito do seu instrumento de adesão junto do Governo dos Estados Unidos da América.

**Artigo II**

O presente Protocolo entrará em vigor quando todas as Partes no Tratado do Atlântico Norte tiverem notificado o Governo dos Estados Unidos da América da respectiva aceitação. O Governo dos Estados Unidos da América informará todas as Partes no Tratado do Atlântico Norte da data de recepção de cada uma das notificações e da data de entrada em vigor do presente Protocolo.


**Artigo III**

In accordance with article 10 of the Treaty, Romania shall become a Party on the date when it deposits its instrument of accession with the Government of the United States of America.

The Government of the United States of America shall inform all the Parties to the North Atlantic Treaty of the date of receipt of each such notification and of the date of the entry into force of the present Protocol.




