Your Excellency

Dear Janz,

Further to my letter of June 5th, 2018, I am pleased to submit to you the Portuguese Government's projections of increases in defense spending until 2024. I trust you will agree that these projections demonstrate my Government's commitment to a growing trajectory of defense spending over the next several years and to a substantial increase in the amount devoted to investment in capabilities, as called for in the Wales declaration.

These projections are the result of a demanding effort carried out by the Portuguese government as a whole, coordinated by the Prime Minister's office and involving in particular the Ministries of Defense, Foreign Affairs and Finance, as well as the Armed Forces. We have chosen to present realistic, serious and credible paths of defense spending which represent a very ambitious effort to increase our defense spending and our military capabilities, while taking due account of budgetary constraints.

We present two different scenarios, the baseline scenario and scenario B.

Under the baseline scenario, we will increase the share of GDP devoted to

defense to 1.66% of GDP in 2024 and the share of defense expenditures

devoted to capabilities will rise sharply to 17% in the same period. In

addition to the already planned and current investments, this substantial

increase in real expenditure as well as the change in its composition will

allow a very significant improvement in our military capabilities and our

ability to deploy our forces abroad, especially by air and sea.

These numbers may increase in the next few years, depending on several

factors which are still unknown, such as the allocation and the distribution

among the member States of the European Union of funds dedicated to

defense and defense related scientific research. This more favorable

hypothesis, which may lead in 2024 to defense expenditures of 1.98% of

GDP, is reflected in the projection presented as scenario B.

We stand ready to work with the competent NATO authorities to further

detail and specify what this projection entails in a spirit of full cooperation

and transparency and to pursue our efforts to fully achieve, in due time, the

stated goals of the Defense Investment Pledge.
