## Involvement of the National Parliaments concerning the SCP and the NRP

In line with the relevant regulations<sup>1</sup>, national parliaments should be duly involved in the European Semester and in the preparation of Stability/Convergence Programmes (SCP) and National Reform Programmes (NRP) in order to increase the transparency, ownership and accountability for the decisions taken. According these EU rules, each Member States' Stability or Convergence Programme shall include information on its status in the context of national procedures, in particular whether the programme was presented to the national parliament and whether there has been a parliamentary approval of the programme.

The draft table below provides information on the form of involvement of the national parliaments as specified in the text of the SCPs and the NRPs. On the basis of the information available in these Programmes, it can be concluded that in terms of the SCPs, 12 national parliaments were consulted and 6 were informed, while in the case of 6 national parliaments, no information could be found on their roles in the procedure.<sup>2</sup> As far as NRPs concerned, the submitted text indicates that 7 governments consulted their national parliaments and 4 submitted their programmes to their legislators. 13 Member States' NRPs do not contain any reference to the involvement of their national parliaments.
