AATF History

- Created by the Airport and Airway Development and Revenue Act of 1970 to finance aviation programs
 - Revenues are derived from aviation-related excise taxes on passengers, cargo, and fuel
 - Provides funding for capital improvements to the U.S. airport and airways system
 - Provides the majority of funding for the Federal Aviation Administration
 - 66.6% in FY 2010
 - 68.8% in FY 2011
 - 71.1% in FY 2012
 - 71.5% in FY 2013



AATF Funds these Accounts

- FAA accounts:
 - Operations (funded by the General Fund and AATF)
 - Facilities and Equipment¹
 - Research, Engineering, and Development
 - Grants-in-Aid for Airports¹
- DOT accounts:
 - Essential Air Services (EAS)

¹ The General Fund can also contribute to Facilities & Equipment and Airports accounts. An example includes the American Recovery and Reinvestment Act of 2009 (ARRA)


