# Activities of the European Affairs Committee on monitoring the process of withdrawal of the United Kingdom from the European Union

Since the beginning of the process of withdrawal of the United Kingdom from the European Union (*Brexit*), the European Affairs Committee has sought to monitor the several stages of negotiation, as well as to understand the scope of the measures to be implemented, and it is mainly concerned with the rights of Portuguese citizens in the United Kingdom and with the implications of this withdrawal to the Member States as a whole, but also with the implementation of a thoughtful and transparent process.

Therefore, the European Affairs Committee, which scrutinises the varied topics on the European agenda by creating monitoring dossiers per topic, has designated two permanent rapporteurs for each of the 8 dossiers set to date.

Regarding the dossier on the *Process of withdrawal of the United Kingdom from the European Union (BREXIT)*, had as permanent rapporteurs during the XIII Legislature, the MP Rubina Berardo (PSD) and MP Carla Tavares (PS), who monitored the work of the Committee on this matter.

In addition, the European Affairs Committee held several hearings on this issue, namely with the Ambassador of the United Kingdom to Portugal, Kirsty Hayes, always focusing on topics related to the rights of citizens, issues linked to the relationship with Ireland and the Union's borders, as well as maintaining the bilateral relations between Portugal and the United Kingdom. Was also held a hearing on February 6, 2019 with the Ambassador Christopher Sainty, who took office after the former Ambassador.

The European Affairs Committee held two public hearing sessions on Brexit, inviting several entities proposed by the different Parliamentary Groups, representing various areas of activity.

The European Affairs Committee held hearings with various members of the Government, namely the Minister of Foreign Affairs, the Minister of Finance, the Minister of Science, Technology and Higher Education, the Minister of Home Affairs, the Minister of Economy and the Secretary of State for Tourism, as well as the Secretary of State for Agriculture and Food, in order to better understand Brexit's sectoral impacts.

Other hearings were held by the European Affairs Committee, namely with Dr. Luís Araújo, President of Turismo de Portugal, in order to better inform about the impacts of Brexit on Portuguese tourism and economy, as well as the measures taken to address them, and with Eng. António Saraiva, President of the Portuguese Business Confederation (CIP), accompanied by Dr. Pedro Capucho - Economic Affairs Department and Dr. João Almeida - CIP Vice President, to present the study "The economic consequences of Brexit for the economy and the Portuguese companies".

The Committee also heard the EU Chief Negotiator for this process, Michel Barnier, and the transparency of the negotiation, the required solidarity between Member States, the protection of the rights of citizens living in the United Kingdom and of UK citizens living in other Member States, the financial agreement, and the border issue with Ireland were highlighted.

The presence of Lord Boswell, Chairman of the European Union Select Committee of the House of Lords in the UK Parliament, in the European Affairs Committee to debate topics related to the process of withdrawal of the United Kingdom should also be mentioned, pointing to the relevance of the issues raised by this process, namely in what concerns the citizens, advocating for the protection of the terms of parliamentary scrutiny on this matter and the need to avoid an abrupt exit by the

United Kingdom, additionally mentioning the importance of the bilateral relations between Portugal and the United Kingdom.

Regarding concerns with the issues facing Ireland in this process and other related topics, a hearing was promoted with Ireland's Minister for European Affairs, Helen McEntee.

Invitations for a hearing in the European Affairs Committee were also addressed to Ambassador João de Vallera, as coordinator of the task-force for Brexit, and Bernardo Trindade, as President of the *Portugal IN* Mission Structure Executive Committee, and the hearings were consecutively held on 11 July 2017.

Several requests presented by parliamentary groups were approved by the Committee in relation to *Brexit* and for scheduling hearings with the Ambassador of the United Kingdom to Portugal in order to get an update on the situation, whenever necessary, as well as with Bernardo Trindade and Sofia Alves, Head of the European Commission Representation in Portugal.

Therefore, the European Affairs Committee also heard, whenever relevant, if requested or imposed by the Law on Monitoring, assessment and pronouncement by the *Assembleia da República* within the scope of the process of constructing the European Union, the Minister for Foreign Affairs and/or the Secretary of State for European Affairs, mainly after European Council meetings to debate its conclusions.

The Chairwoman of the European Affairs Committee also granted several audiences on this issue, namely with the Ambassador of the Republic of Ireland to Portugal, Orla Tunney, for a courtesy visit prior to the meeting with Ireland's Minister for European Affairs, Helen McEntee (June 2018). This audience mainly focused on the impact of *Brexit* on Ireland, the progress in the negotiations and the difficult situation in the United Kingdom, as well as the challenges regarding



Northern Ireland, and other items on the European agenda such as migration and the multiannual financial framework.

Other audiences with Kirsty Hayes, Ambassador of the United Kingdom, on the speech given by the Prime Minister, Theresa May, in Florence (October 2017) about the negotiations for the withdrawal of the United Kingdom from the European Union, and with Antoine Comte-Bellot, Diplomatic Advisor to the Embassy of France and Isabelle de Frayssinet, Advisor for European Affairs to the Embassy of France on *Brexit* (April 2017) are worth mentioning.

Within the scope of the legislative initiative, the PSD Parliamentary Group submitted a Draft Resolution on – Recommendation to the Government for the urgent execution of a study on the implications of the withdrawal of the United Kingdom from the European Union to the Portuguese economy – which was debated in the European Affairs Committee and approved in plenary sitting in December 2017.

Also in the framework of the legislative initiative, the Government introduced the Bill No. 187 - *Aprova medidas de contingência a aplicar na eventualidade de uma saída do Reino Unido da União Europeia sem acordo*<sup>1</sup> - discussed in the European Affairs Committee. This Bill was approved in a plenary session of Assembleia da República, on the 27 March 2019, with the Committee proposing a replacement text.

Despite the monitoring by the *Assembleia da República*, the European Affairs Committee carried out, on 5-7 February 2018, a working visit to the British Parliament and on 16-17 April 2019, a working visit to the Irish Parliament and border between the Republic of Ireland and Northern Ireland, as part of the ongoing *Brexit* process, one of the priority items on the Committee's agenda.

At the working visit to the British Parliament, the delegation was composed of the Chairwoman of the Committee, MP Regina Bastos, MP Inês Domingos (PSD), MP Carla Tavares (PS), MP Isabel Pires (BE), MP Miguel Tiago (PCP) and MP Pedro Mota Soares (CDS-PP).

The visit to the British Parliament foreseen in the activity plan of this Committee involved meetings with two House of Commons Committees, and their Chairs: Hilary Benn, Chair of the Committee on Exiting the EU e William Cash, Chair of the European Scrutiny Committee. The meeting with the European Union Select Committee of the House of Lords was also accompanied by its Chair, Lord Boswell of Ayhno.

These meetings, which focused on deepening the inter-parliamentary political debate and in particular *Brexit*, were also attended by the Ambassador of Portugal to the United Kingdom, Manuel Lobo Antunes, and the two main concerns in this process in connection with the protection of the rights of Portuguese citizens in the United Kingdom and maintaining the bilateral relations between both States were addressed.

At the working visit to the Irish Parliament and the border, the delegation was composed of the Chairwoman of the Committee, MP Regina Bastos, MP Maria Luís Albuquerque (PSD), MP Vitalino Canas (PS), MP Isabel Pires (BE) and MP Paula Santos (PCP).

The working visit to the Irish Parliament, foreseen in the activity plan of this Committee, involved the visit to the Killeen border and meetings with the Newry Chamber of Commerce, represented by its CEO Colm Shannon and other individuals. The meeting with the Department of Foreign Affairs was accompanied by the Directors Ruth Parkin and Conleth Brady. The delegation also met with Seanad Special Select Committee, President Senator Neale Richmond, Dáil Éireann President, Oireachtas Iower house, Seán Ó Fearghaíl TD and Seanad

Éireann President Senator Denis O'Donovan. The delegation was received at the Joint Committee on European Union Affairs by its Chairman, Mr Michael Healy-Rae TD and present members.

These meetings, which focused on deepening the inter-parliamentary political debate and in particular Brexit, were also attended by the Ambassador of Portugal in Dublin, Dr. Miguel Almeida e Sousa and the Head of Mission, Dr. Rogério Alves, and the three main concerns in this process in connection with the protection of the rights of Portuguese citizens in the United Kingdom and Ireland, the backstop and possibility of physical border and maintaining the bilateral relations between Portugal and the Republic of Ireland and Northern Ireland.

There were several interventions by Members of the European Affairs Committee in inter-parliamentary meetings related to the challenges in this process, specifically mentioned by the Chairwoman of the European Affairs Committee in COSAC Chairs meetings and in the COSAC plenary meeting.
