This regulation, performed by a legal regulatory body composed by physiotherapists, is fundamental to compulsory comprise all the physiotherapists in the Portuguese territory to control the quality standards of education and the liberal profession. These recommendations are aligned with the professional definition of ESCO <https://ec.europa.eu/esco/portal/occupation>, with the recommendations of the World Confederation of Physiotherapy (WCPT) <http://www.wcpt.org/policy/ps-autonomy> and with the many professional bodies with legal regulation of the profession in European countries, like in United Kingdom, The Netherlands, Denmark, Finland, Iceland, Malta, Belgium, Bulgaria, Cyprus, France, Hungary, Latvia, Lithuania, Luxembourg, Norway, Serbia, Spain, Sweden and in non-European countries like in United States, Australia, Canadá, Japan, New Zealand.

Professional autonomy requires differential diagnostic competences, diagnose in physiotherapy, clinical decision making informed by the best updated scientific evidence and specialised intervention skills, all competences that are obligatory to be included in both bachelor and master programmes in physiotherapy.

Knowing the higher educational institutes in Portugal and their scientific programmes, we consider the Portuguese Physiotherapists as, well prepared professionals with high standards of professionalism and high level of competences for autonomous liberal profession. Consequently, requiring a professional regulatory body constituted by physiotherapists, for obligatory registration to assure quality for the practice of the profession towards the citizens.
